CONTRACTUAL PENALTIES FOR VIOLATIONS IN WORK SAFETY, FIRE SAFETY, ELECTRICAL SAFETY, ENVIRONMENT AND WORK MANAGEMENT REQUIREMENTS

- SCHWENK Latvija SIA (hereinafter SCHWENK) has the right to withhold from the payment set in the Agreement to the
 ______ (hereinafter the Contractor) the Contractual Penalty set in this Appendix to the Agreement or to request its
 payment from the Contractor for violations of work safety, fire safety, electrical safety, environment and/or work management
 requirements set in appropriate legislation and/or set by SCHWENK.
- 2. The Contractual Penalty is calculated for each separate violation or for each employee violating the requirements.
- 3. The Contractual Penalty is calculated for documented cases (in writing, photo, video).
- 4. The Contractual Penalty is also calculated for violations by subcontractors employed by the Contractor.
- 5. SCHWENK responsible employees shall assess the substance of the violation, its conditions, impact, and the offender's attitude, and can change the amount of the contractual penalty decrease (for maximum 50%) or increase (for maximum 100% if any of the violations create increased danger and/or serious threat to the life and health of people and/or to natural environment) it.
- 6. The offending employees receive individual disciplinary penalty in accordance with 'Subcontractor Disciplinary Case Assessment Card'.
- 7. If losses have arisen to SCHWENK due to violations of work safety, fire safety, electrical safety, environment and/or work management requirements, they are calculated and recovered from the Contractor separately.
